

## **Matching Gifts Program**

Employee contributions of at least \$100 that are made to eligible nonprofit organizations will be matched by Starr Companies – up to \$3,000 per calendar year.

Starr Companies will match dollar-for-dollar contributions by eligible donors and/or their spouses to eligible organizations that qualify as tax-exempt organizations for federal income tax purposes under section 501 (c) (3) of the Internal Revenue Code. Eligible organizations must meet the guidelines as stated in the company Matching Gifts Program policy.

What a great opportunity for the organization – When you make a contribution to an eligible nonprofit organization, they receive two donations – your contribution and the matching gift from Starr Companies.

You may designate that your contribution be used for a particular purpose; however, the matching gift will be made for unrestricted use by the recipient institution.
